Conduct a noticed public hearing to consider Use Permit application U-24-08 by Complete Wireless Consulting, Inc for Verizon to establish a new wireless communication facility consisting of an 80' monopole within a 2,500 square foot lease area located at 5778 Dixon Avenue West, located one mile east of the City of Dixon in the Exclusive Agriculture 40-acre minimum (A-40) zoning district, APN 0109-020-080. The project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303, New Construction or Conversion of Small Structures.

Planning Manager Allan Calder introduced Associate Planner Travis Kroger who presented the Use Permit application U-24-08 to the Commission. Chris Ferrucci, County Surveyor, the applicant and the landowner were present.

Kevin Gallagher, representing Verizon, presented a brief project summary noting that Staff requested several alternate colors and had suggested "Threshold Taupe". Mr. Gallagher recommended "Gray" as it fit the color of the

sky better and was less obtrusive.

Commissioner Richardson commented that the color gray aligns with how the United States Air Force chooses their colors regarding military aircraft.

*Chairperson Bauer opened the public hearing. There was no public comment and Chairperson Bauer closed the public hearing.*

Commissioner De La Rosa requested clarification on whether the County has a stealth requirement in its ordinance. Travis Kroger commented that it should be considered and implemented when possible but is not a requirement to implement. Mr. Calder commented that the language allows discretion; it is an option, not a requirement.

Commissioner De La Rosa commented for future reference, that any staff report coming to the Commission with regard to cell towers should contain some language that staff has considered the stealth requirement and what recommendations have been suggested.

**On motion of Commissioner Cayler, seconded by Commission De La Rosa, the Commission adopted the resolution with revision to the color Grey, and approved item PC 25 003, Use Permit application U 24 08 by Complete Wireless Consulting, Inc. for Verizon. So ordered by 5 0 vote. (Resolution No. 4741)**

## **ANNOUNCEMENTS AND REPORTS**

Mr. Bezek stated that staff would like to bring forward to the Commission a recommendation to consider changing the meeting start time to either 6:00 p.m. or 6:30 p.m. He also stated the Chair could, on an individual basis, set a start time for the next meeting.
